

VpCI®-408 Mild Alkaline Cleaner



PRODUCT DESCRIPTION

VpCI-408 is a mildly alkaline blend of surfactants for use in high-pressure spray washers, and power washing machinery. It can be used for removal of machining fluids, coolants, light oils, and greases. VpCI-408 is near neutral in pH, which eliminates the need for some wastewater treatment.

VpCI-408 is a non-foaming alkaline cleaner that provides multi-metal corrosion protection after the cleaning process. Even at low concentrations, VpCI-408 can provide corrosion protection to metal parts that are stored inside.

VpCI-408 is also available in a super concentrate version as VpCI-408 SC.

- Mild alkaine cleaner and degreaser for use in high-pressure spray systems

- Contains inhibitors for multimetal protection
- Requires mechanical action to be effective
- Leaves no residual film

- Plate, sheet metal, and metal castings covered with oily films prior to painting or pickling
- Metal parts contaminated with typical machining or drawing fluids
- Pressure washing

APPLICATION

VpCI-408 can be applied using power washers and sprayers. For best results, it is recommended that this product be used at a temperature of 120-150°F (49-66°C).

Mix VpCI-408 into water to desired concentration. Maintain solution by monitoring pH, refractometry, and titration.

RECOMMENDED DILUTIONS

<u>Light Cleaning:</u> Use 2% (by weight) VpCI-408 in water.

<u>Normal Cleaning:</u> For heavier oils, use 3-5% (by weight) VpCI-408 or 1-3% VpCI-408 SC in water.

<u>Heavy-duty Cleaning:</u>

For drilling oils and heavy greases use 5-10% (by weight) VpCI-408 in water.

MONITORING CONCENTRATIONS

- Concentration should be monitored regularly to ensure product effectiveness
- Monitoring can be performed via pH or refractometry

<u>pH</u>

• For 2-20% (by weight) solutions, pH range should be from 8.8-9.0

Refractometry

- Refractometer reading can be measured using refractive index or Brix scale
- Refractive index measurement should be between 1.333 and 1.337 for solutions of 2-20%
- For Brix scale readings, please refer to the following chart



***Note:** Refractometer and pH readings may vary depending on water quality. The solutions analyzed above were diluted with deionized water.
